Pursuant to and in accordance with Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with SEBI Circular No. SEBI/HO/CFD/CMD1/CIR/P/2019/140 dated November 21, 2019, and the SEBI Master Circular dated July 11, 2023, the litigation involving the Company, including our Key Managerial Personnel (KMPs) and Directors, which was previously intimated to the exchange on June 14, 2024, vide Ref: SIL/2024-25/20, has now been settled and closed.

**A. Brief of Details of Litigations:**

**B. Date of the receipt of the Order:** Order dated 17<sup>th</sup> October, 2025, received on 22<sup>th</sup> of October, 2025.

**C. Outcome of the Order:** The parties have arrived at a compromised and the present case is dismissed as withdrawn.

**D. Financial Impact on the Company:** In connection with the settlement of the ongoing matter with M/s QP Pharmachem, the Company has, till date, made payment of ₹3,95,40,393/- (Rupees Three Crore Ninety-Five Lakh Forty Thousand Three Hundred Ninety-Three only) out of total settlement amount of INR 5,18,00,000/- towards the disposal of the said case.

Further, the Company has issued a cheque amounting to ₹1,22,59,607/- (Rupees One Crore Twenty-Two Lakh Fifty-Nine Thousand Six Hundred Seven only) to M/s QP Pharmachem, which shall be utilized by the said party only in the event of a dollar exchange difference payable towards remittance to the concerned overseas entity in China. The said cheque shall remain unutilized in the absence of any such exchange rate variation.

This disclosure is being made in compliance with the Minimum Disclosure Standards prescribed under the aforementioned SEBI circular.
