हरियाणा विस का मानसून सत्र 25 अगस्त से

चंडीगढ्, ४ अगस्त (जनसत्ता)।

हरियाणा विधानसभा का मानसून सत्र 25 अगस्त से आरंभ होगा। हरियाणा के मुख्यमंत्री मनोहर लाल की अध्यक्षता में शुक्रवार को चंडीगढ़ में हुई बैठक में यह फैसला लिया गया। मानसून सत्र 29 अगस्त तक चलने की संभावना है। इसके बावजूद सत्र की अवधि अंतिम फैसला

मंत्रिमंडल की विधानसभा की बिजनेस | सलाहकार समिति द्वारा बैठक में लगी मानसून सत्र की लिया जाएगा। मानसून सत्र अधिकतम तीन दिन का तारीख पर मुहर होगा, लेकिन इसके बहुत बिंजनेस ज्यादा हंगामेदार रहने के परामर्श समिति आसार हैं। विधायकों से तय करेगी सत्र मानसून सत्र में लगाने के की समयावधि।

लिए सवाल मांग लिए गए हैं। कई विधायकों ने अपने सवाल विधानसभा सचिवालय को दे भी दिए हैं।

अतिरिक्त मुख्य सचिव (गृह) टीवीएसएस प्रसाद की ओर से तीन अगस्त को जारी सरकारी आदेश के अनुसार, सिंगला की अनुपस्थिति में अतिरिक्त प्रभार संभाल रहे नरेंद्र बिजारनिया को नूह का एसपी नियुक्त किया गया है। आदेश में कहा गया है कि नूंह के वर्तमान एसपी का तबादला कर उन्हें भिवानी का एसपी नियुक्त किया जाता है तथा भिवानी के एसपी बिजारनिया को तबादले के बाद नूंह का एसपी नियुक्त किया जाता है।

बिजारनिया नूंह और आसपास के इलाकों में कानून और व्यवस्था की स्थिति बनाए रखने में अपनी जिम्मेदारी निभाने के लिए अतिरिक्त पुलिस महानिदेशक (कानून और व्यवस्था) के वास्ते बतौर विशेष ड्यूटी अधिकारी के रूप में भी कार्यरत थे। वहीं, धीरेंद्र खड़गटा को उपायुक्त नियुक्त किया गया है। पिछले दिनों विहिप का जुलूस रोकने की कोशिश को लेकर भड़की हिंसा में दो होम गार्ड और एक मौलवी समेत छह लोगों की जान चली गई थी।

हरियाणा के गृह मंत्री अनिल विज ने कहा कि नूंह में पुलिस लगातार तैनात है और हालात पर पैनी नजर रखी जा रही है। अब तक हिंसा के मामलों में 102 प्राथमिकियां दर्ज की जा चुकी है और 202 लोगों को गिरफ्तार भी किया जा चुका है। शुक्रवार को गृहमंत्री विज ने पत्रकारों से बातचीत में जानकारी देते हुए बताया कि 80 लोगों को हिरासत में लिया गया हैं। उन्होंने जानकारी देते हुए कहा, 'किसी निर्दोष को सजा न मिले और कोई दोषी न छूटे, इसी सिद्धांत पर पुलिस कार्य कर रही है। इसलिए पुख्ता सबूत जुटाकर कार्रवाई की जानी है और एक भी दोषी को बख्शा नहीं जाएगा। उन्होंने कहा कि जिन लोगों को पकड़ा गया है, उनसे गहन पूछताछ की जा रही हैं और जो जानकारियां

मिल रही हैं, उनके अनुसार कार्रवाई की जा रही हैं। मौलवियों से भी बातचीत की गई है और मौलवियों ने आहवान किया है कि घर पर ही नमाज पढी जाए, यदि वे ऐसा करते हैं तो बहुत अच्छी बात है। सोशल मीडिया के संबंध में पुछे गए सवाल के जवाब में उन्होंने कहा कि सोशल मीडिया की निगरानी व स्कैंनिंग के लिए गृह विभाग के विशेष सचिव की अध्यक्षता में एक सिमित का गठन किया गया है, जिसमें आइटी इकाई से भी अधिकारी को लिया गया हैं जो सोशल मीडिया को स्कैन करेगी। यदि सोशल मीडिया पर कुछ लोगों द्वारा भड़काऊ पोस्ट डाली गईं होंगी तो कार्रवाई होगी। एसआइटी के गठन पर कहा कि जैसे-जैसे जहां-जहां जरूरत पड़ेगी, दोतीन पुलिस अधिकारियों/कर्मचारियों की एसआइटी बनाकर उन्हें जांच सौंपी गई है

ताकि एक-एक मामले की जांच हो सके।

आम आदमी पार्टी ने चंडीगढ़ में मांगा भूखंड, चेतावनी देकर कहा

राजभवन के बाहर खोलेंगे पार्टी कार्यालय

चंडीगढ, ४ अगस्त (जनसत्ता)।

आम आदमी पार्टी 'आप' ने शुक्रवार को धमकीभरे लहजे में कहा कि यदि उन्हें जल्द ही चंडीगढ़ में पार्टी कार्यालय खोलने के लिए यहां जमीन आबंटित नहीं की गई तो वह लोग पंजाब राजभवन के बाहर से ही कार्यालय चलाना शुरू कर देंगे। यहां पत्रकारों से चर्चा में पंजाब 'आप' के मुख्य प्रवक्ता मालविंदर सिंह कंग ने पंजाब के राज्यपाल एवं चंडीगढ़ के प्रशासक बनवारी लाल पुरोहित पर पार्टी को जान-बूझकर जमीन नहीं देने का आरोप लगाते हुए कहा कि वह मनमानी पर उतारू हैं।

कंग ने यहां तक कहा कि राष्ट्रीय पार्टी होने व पंजाब में उसकी सरकार होने के बावजूद राज्यपाल 'आप' को चंडीगढ़ में पार्टी कार्यालय के लिए जमीन देने को तैयार नहीं। उन्होंने आरोप लगाया कि भाजपा दरअसल राज्यपाल का इस्तेमाल कर चंडीगढ़ पर पंजाब

और यही वजह है कि पंजाब में सत्तारूढ़ आम आदमी पार्टी को चंडीगढ में कार्यालय स्थापित करने के लिए जमीन नहीं दी जा रही।

उन्होंने कहा कि पंजाब 'आप' के अध्यक्ष और मुख्यमंत्री भगवंत मान ने इसके लिए राज्यपाल बनवारी लाल पुरोहित को तीन-तीन बार पत्र लिख भेजे हैं। इसके अलावा, पार्टी सचिव और महासचिव ने भी चंडीगढ़ प्रशासन व राज्यपाल को पत्र लिखे लेकिन बावजूद इनके जान-बूझकर अनदेखी की जा रही है।

कंग ने यह सवाल भी उठाया कि भाजपा और कांग्रेस दोनों के ही चंडीगढ़ में कार्यालय हैं। वह भी तब जब भाजपा के पंजाब विधानसभा में मात्र दो निर्वाचित विधायक हैं। अकाली दल का भी चंडीगढ़ में कार्यालय है, तो ऐसे में 'आप' को उसका कार्यालय खोलने के लिए यहां जमीन देने में यूटी प्रशासन को क्या परेशानी है? उन्होंने कहा कि चंडीगढ में

पाने की 'आप' हर तरह से पात्र है। उसकी पंजाब और दिल्ली में सरकारें चल रही हैं. गुजरात और गोवा विधानसभा में उसके निर्वाचित विधायक हैं। लोकसभा में उसका एक सांसद जबिक राज्यसभा में उसके 10 सदस्य हैं। यहां तक कि स्थानीय चंडीगढ नगर निगम में सर्वाधिक 14 पार्षद 'आप' के ही हैं। तो ऐसे में चंडीगढ़ प्रशासन यहां चंडीगढ़ में आम आदमी पार्टी को कार्यालय स्थापित करने के लिए जमीन आबंटित करने से इनकार क्यों

कंग ने राज्यपाल को चेतावनी देते हुए जल्द से जल्द फैसला लेते हुए 'आप' को चंडीगढ़ में पार्टी कार्यालय स्थापित करने के लिए भूखंड आबंटित करने की सलाह दी और कहा कि वरना विरोधस्वरूप वह पंजाब राजभवन के बाहर से ही पार्टी कार्यालय संचालित करने को विवश होंगे।

चंडीगढ़ में महिला और युवक सहित नशा तस्कर गिरफ्तार

चंडीगढ़, ४ अगस्त (जनसत्ता)।

पुलिस ने शहर में नशा तस्करी के आरोप में एक युवक सहित दो आरोपियों को गिरफ्तार किया है। इनमें हिमाचल में सोलन के निवासी आशीष ठाकुर चंडीगढ़ में मादक पदार्थ बेचता था और उसने सिविल इंजीनियरिंग की पढ़ाई की है। उसके पिता सीआइएसएफ में निरीक्षक पद से सेवानिवृत्त हैं। उस पर मोहाली में भी नशा तस्करी का मामला दर्ज है, जिसमें वह जमानत पर रिहा हुआ था।

उससे पुलिस की ओर से की गई पूछताछ में पता चला है कि वह हिमाचल के निवासी सावन बोध नामक एक व्यक्ति से मादक पदार्थ लाकर चंडीगढ़ में बेचने को गोरखधंधा करता था। पुलिस ने उसे भी गिरफ्तार कर लिया है

और पूछताछ की जा रही है। एक अन्य मामले में पुलिस ने निशांत

पुलिस के मुताबिक, आरोपी नशा तस्कर के खिलाफ पहले से ही पांच मामले चल रहे हैं। इसकी महिला साथी का पति भी नशा तस्करी के आरोप में जेल में बंद है जिसे मोहाली पुलिस ने गिरफ्तार किया है।

गोयल को 62 ग्राम मादक पदार्थ के साथ गिरफ्तार किया है जो अपनी एक महिला साथी के खाते में पैसे डलवाता था और उसके बाद उससे पैसे वापस लेता था। पुलिस ने इस महिला को भी गिरफ्तार कर लिया है।

पलिस के मताबिक, आरोपी के खिलाफ पहले ही पांच मामले चल रहे हैं। इसकी महिला साथी का पति भी नशा तस्करी के आरोप में जेल में बंद है जिसे मोहाली पुलिस ने गिरफ्तार किया है।

पंजाब : बीएसएफ जवानों की ओर बढ़ रहे व्यक्ति को मार गिराया

अमृतसर, ४ अगस्त (भाषा)।

पंजाब में सीमा सुरक्षा बल (बीएसएफ) के जवानों ने शुक्रवार की अलसुबह भारत-पाकस्तान सीमा पर भारतीय सीमा में लगाई गई सुरक्षा बाड़ के समीप उनकी ओर 'आक्रामक' तरीके से आगे बढ़ रहे एक अज्ञात शख्स को मौके पर ही मार गिराया। इस आशय की जानकारी शुक्रवार को आला बीएसएफ के अधिकारियों की ओर से दी गई। इस बारे में बीएसएफ के एक आला अधिकारी की ओर से प्रदत्त जानकारी में बताया गया कि यह घटना तरनतारन में पड़ते गांव भिखीविंड-खालरा के समीप शुक्रवार की सुबह करीब चार बजे हुई थी।

उन्होंने बताया कि बीएसएफ जवानों ने उस व्यक्ति को अपनी ओर आते देखा तो उसे कई बार चेतावनी दी। इसके बावजूद जब वह आक्रामक रूप से उनकी ओर आगे बढ़ने लगा तो सैनिकों ने आत्मरक्षा में गोलियां चला दीं। पुलिस अधिकारी ने जानकारी देते हुए बताया कि मारे गए इस व्यक्ति की पहचान की जा रही है।
